



Dear Customer

as you may know, starting from next 4<sup>th</sup> July 2020, EU regulation n.2017/1000 amending Annex XVII to Regulation (EC) No 1907/2006 of the European Parliament and of the Council concerning the Registration, Evaluation, Authorization and Restriction of Chemicals (REACH) as regards perfluorooctanoic acid (PFOA), its salts and PFOA-related substances comes into force and effect.

This EU regulation sets limits for PFOA and its salts and also for products containing these substances. The restrictions on the use of substances states:

- PFOA and its salts shall not be manufactured, or placed on the market as substance on their own form.

The substances are also restricted in mixtures and in articles as below:

- PFOA and its salts shall not be used in the production of, or placed on the market in:
  - Another substance, as a constituent;
  - A mixture;
  - Any part of an article

in a concentration equal to or above 25 ppb of PFOA including its salts or 1 000 ppb of one or a combination of PFOA-related substances.

All these restrictions will be applicable from 4 July 2020.
